- Mobilize the meme machine – Flood the digital landscape with Frog Knox supremacy.

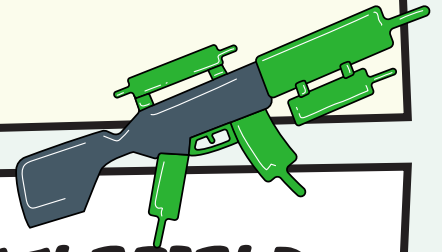
